DECLARATION MUST BE SIGNED BY PERSONS WHO DO NOT HOLD A VALID FIREARMS CERTIFICATE

Article 37 of the Firearms (Jersey) Law 2000 prohibits the possession of firearms for specific periods by persons who have received certain custodial sentences. Any person sentenced to imprisonment for a term of three years or more shall be prohibited for life, and any person sentenced to imprisonment for a term of three months or more (but less than three years) shall be prohibited for a period of five years from the end of their sentence.

IMPORTANT NOTES

- 1) The Committee has the right to refuse entry to the Club without explanation.
- 2) The Jersey Pistol Club's ranges may only be used under the control of an authorised Range Officer.
- 3) **If you are under the age of 18, a parent or guardian must countersign this form.** The minimum age for full membership is 17, but Junior Members are welcomed at the Committee's discretion.
- 4) In the case of a **Joint Membership, both parties** (Applicant and Spouse/Partner) **must complete an individual application form and be living at the same address.**
- 5) You may use a Provisional Membership Card for up to 3 visits to the club, before applying for Full Membership. If you choose not to apply for Full Membership you may, at the Committee's discretion, continue to use the ranges at the standard Provisional Member rates provided that you are a member of another shooting club and/or possess a valid Firearms Certificate or Permit.
- 6) Provisional and new members are advised to carry their membership cards when on the range. Any club official is entitled to bar an individual from participating where their membership cannot be confirmed.
- 7) All users must display to the Range Officer a satisfactory standard of safety, gun handling, and range discipline at all times. Adverse reports are likely to lead to the rejection of a membership application, or suspension, or even termination of membership.
- 8) Visitors and new members must attempt to qualify as safe and competent shooters by achieving the following standards.
 - a. score a minimum total of 300, on 4 consecutive PL7 targets, single handed, at a distance of 13 metres, using a .22 calibre pistol before progressing to other targets or distances.
 - b. score a minimum total of 280 on 4 consecutive PL7 targets, single handed, at a distance of 25 metres, using a .22 calibre pistol before progressing to centrefire pistols.
 - c. score a minimum total of 300, on 4 consecutive standard PL7 targets, either single or double handed, at a distance of 13 metres, using a centrefire pistol before progressing to other targets or distances.
 - d. All pass scores to be confirmed and recorded by the Duty Range Officer in the Score Register.
- 9) **Visitors and new members who claim experience, but whose proficiency is unknown to the Duty Officer, should be tested on a PL7 or PP1(PPS14) target at 25m with the pistol they wish to use. A pass score is 75 on a PL7 target, or 90 on a PP1(PPS14) target.**
- 10) Annual subscription rates for 2021 are:
 - Full Member £26.00
 - Joint Full Members £32.00 **(both parties to complete separate forms and living at the same address)**
 - Student or Junior £7.00
 - Non-resident £11.00
 - Joint Non-residents £13.00 **(both parties to complete separate forms and living at the same address)**
- 11) The membership year is from 01 February through 31 January. New members joining after the end of February will have their first year's subscription pro-rated – at a rate of 1/4 per expired quarter of the year. Thus, a new Full Member applying to join will pay Feb £26 May £19.50, August £13, November £6.50.
- 12) When completed, this form should be posted to the Membership Secretary (Mr. John Gamlin, 2 Champ des Arbres, La Verte Rue, St. Mary, Jersey, JE3 3DA) for consideration at the next Committee Meeting. Fees may be submitted with the application or given to the Range Officer.
